

Special Needs Registry and Transportation Disadvantage



As hurricane season concludes, it's crucial to remain alert and prepared. Recent Hurricane Helene highlighted the need for evacuation transportation, which Franklin County Emergency Management provides for residents without transportation during mandatory evacuations. Residents must apply for this Sean Me service, which only transports them to designated shelters, considered a last resort.

Additionally, Franklin County collaborates with the Florida Department of Health to maintain a Special Needs Registry for individuals requiring extra assistance during evacuations due to disabilities. Special needs shelters are available for those needing more care than general shelters offer and may be activated during emergencies. These shelters aim to support individuals' health requirements, especially for those who are medically stable but need help with basic tasks or use Special Needs Registry electronic medical devices. Pre-registration is advised for those who qualify.



FEMA Disaster Assistance

Although the FEMA Disaster Recovery Centers in Franklin County have now closed, there remains an option for individuals who were unable to visit any of the locations previously offered to apply for assistance.
